Artistic Director and Founder of the Illinois Ballet and Director of the Central Illinois Dance School - a not-for-profit dance company and school 1999 - 2005 Duties: For the Illinois Ballet: choreographed and presented Holiday Spectacular (included Rudolph, the Red Nose Reindeer, restaged the second act of Giselle, choreographed Vienna Waltzs, restaged Le Corsaire Pas de Deux, restaged Don Quixote Pas de Deux), choreographed Rock Ballet, choreographed The Lion, the Witch, and the Wardrobe, restaged Coppelia November 2002, and Sleeping Beauty November 2003, Swan Lake in 2004. During the Spring 2000, we toured to Pennsylvania to perform mixed repetory with the orchestra in Meadville, Pennsylvania, and again in the Spring 2001, we toured to Pennsylvania to perform The Little Mermaid of Lake Erie, choreographed Appalachian Spring, Nutcracker, and the opera Rigoletto, Don Giovonni, Hansel and Gretel, and Il Trovatore. In the Spring 2002, choreographed and restaged for The Power of Dance which included Capriole Suite, Black Swan Pas de Deux, Ballet Etudes, Mission, and Inspiration. For the dance school I teach ballet, pointe, pas de deux, men's ballet class, and modern dance to students ages 11 years and up and professional dancers. My choreography of Mission was selected for Dance Chicago, and one of my company dancers performed it in Chicago in November 2003. Spring 2005 - choreographed the full length Carmina Burana. In August, 2004, The Illinois Ballet, toured Panama City, Panama and performed with The National Ballet of Panama, where I taught all of the combined company classes.

With him I co-choreographed The Nutcracker and Coppelia, and combined the dance majors with his professionally paid dancers and the students of the Lake Erie Ballet School), (5) created a touring dance company: The Mercyhurst Dancers - we did approximately 15 lecture demonstrations in the public and private schools each year I was there with a full one hour program, plus we performed with other arts in First Night Eric, etc., (7) got the dance department active in the American College Dance Festivals.
